
### MESSAGE



## **MULTI-PURPOSE LEGAL AWARENESS CAMP AT BETALGHAT:**

During the said Multi-Purpose Camp, a total number of **696 persons** were benefited by providing them certificates of Widow Pension, Abandonment Pension, Old Age Pension, Divyang Pension, Kisaan Pension, National Family Benefit Scheme, Wheel Chairs, Walking Sticks, Hearing Aids, registration with Labour Department, Scholarship, Pradhanmatri Jan Dhan Yojna, BPL Certificates, MGNREGA Job Cards, Copy of the Family Registers, certificates were issued by the Revenue Department, Ration Cards were made online, distribution of Medicines, Ortho OPD, Sugar Test, Golden Cards, Aadhar Card Modification, Ujjwala Gas Form, Disability Certificate etc.

**DEHRADUN (10 Jan, JNN):** बालक से होटल में काम करवाने के मामले में पटेलनगर पुलिस ने होटल मालिक के खिलाफ केस दर्ज किया है. शिकायतकर्ता सुरेश उनियाल, राज्य समन्वयक बचपन बचाओ आंदोलन ने बताया कि विभिन्न संस्थाओं के सदस्यों के सहयोग से वह शनिवार को प्रतिष्ठानों में काम कर रहे बच्चों को रेस्क्यू करने के

लिए गए थे. इस दौरान आईएसबीटी के पास विस्मिल्ला होटल में 12 साल का बालक खाना बनाता मिला. वहाँ मौजूद कुछ लोग ने कार्यवाही में व्यवधान डालने की कोशिश की. बालक ने बताया कि मालिक उससे साफ-सफाई, झाड़ू पोछा करवाता है. उसे दो हजार रुपये वेतन दिया जाता है. पुलिस ने आलीम मालिक के खिलाफ केस दर्ज कर लिया है.

## एक युवती को नशे की लत से छुटकारा दिलवाया

- सचिव, जिला विधिक सेवा प्राधिकरण, देहरादून को सूचना मिली कि एक युवती निवासी टपकेश्वर रोड, गढ़ी कैण्ट, देहरादून जोकि 19 वर्ष की थीं, 04 साल से नशे की लत में डूब रही थीं।
- उस युवती के नशे की लत के कारण उसके माता-पिता के बीच भी आपसी झगड़ें इतने बढ़ गये थे कि उन दोनों का साथ रहना मुश्किल हो गया था एवं नोबत तलाक तक पहुँच गयी थीं।
- तत्पश्चात् दोनों दम्पति ने अपनी समस्या के निवारण हेतु जिला विधिक सेवा प्राधिकरण, देहरादून से सम्पर्क किया एवं यह कथन किया गया कि वह अपनी पुत्री को जिला विधिक सेवा प्राधिकरण, देहरादून की सहायता से नशे की लत से छुटकारा पाने के उद्देश्य से नशामुक्ति केन्द्र में भर्ती करवाना चाहते थे।
- मामलें को संज्ञान में लेते हुए सचिव द्वारा टीम का गठन कर निर्देशित किया कि वह उस युवती एवं उसके माता-पिता से सम्पर्क कर समस्या का निवारण करें।
- टीम द्वारा युवती से पूछताछ करने पर उसके द्वारा यह कथन किया गया कि वह सभी प्रकार के नशे में लिप्त रहती है। जैसे: धरस, गांजा, स्मैक, भांग, इन्जेक्शन इत्यादि एवं यह भी कथन किया कि वह नशे को छोड़ पाने में असमर्थ है।
- तत्पश्चात् टीम द्वारा उस युवती को काफी समझाने के पश्चात् नशामुक्ति केन्द्र में भर्ती होने हेतु समझाया गया, जिसको काफी प्रयासोंपरांत वह युवती मान गयी।
- तत्पश्चात् प्राधिकरण द्वारा एस0जी0फाउण्डेशन, नशामुक्ति केन्द्र से वार्ता कर उस युवती को निशुल्क भर्ती करने हेतु कथन किया गया, जिस पर कार्यवाही करते हुए उक्त नशामुक्ति केन्द्र द्वारा कोविड-19 टैस्ट करने के पश्चात् उस युवती को निशुल्क भर्ती किया गया।
- परन्तु कुछ समय पश्चात् उस युवती की तबियत खराब हो जाने के कारण उसको अस्पताल में भर्ती करना पड़ा।
- 02 सप्ताह तक अस्पताल में भर्ती रहने के पश्चात् उस युवती को नशे की लत से बाहर निकालने के लिये 03 सप्ताह तक ईलाज किया गया।
- ईलाज के पश्चात् उस युवती के साथ टीम द्वारा काउंसलिंग कर उसे नशे को त्यागने हेतु प्रयास किये गये एवं उस युवती द्वारा भी अपनी सहमति जतायी गयी। अब वह युवती स्वस्थ है एवं नशे की लत से बाहर है।
- अंत में उसके माता-पिता द्वारा जिला विधिक सेवा प्राधिकरण, देहरादून को धन्यवाद दिया गया।

- उक्त बालक की माता की भी मानसिक स्थिति ठीक न होने के कारण बालक के पिता द्वारा कमाई गयी राशि घनराशि बालक की माता के ईलाज में खर्च हो जाती है।
- इसके अतिरिक्त उक्त बालक के 02 भाई बहन है जो सरकारी स्कूल में पढते है परन्तु दिव्यांशु एक प्राईवेट स्कूल में पढ रहा है जिसकी फीस के भुगतान हेतु उसके माता-पिता पर स्कूल द्वारा बार-बार दबाव दिया जा रहा था।
- तत्पश्चात् दिव्यांशु के माता-पिता द्वारा जिला विधिक सेवा प्राधिकरण, देहरादून से मदद मांगी गयी।
- मामले को सर्वोच्चता पर लेते हुए जिला विधिक सेवा प्राधिकरण, देहरादून द्वारा उसकी पढाई जारी रखने हेतु अस्तित्व संस्था से सम्पर्क कर स्कॉलरशिप हेतु वार्ता की गयी जिस पर संस्था द्वारा उक्त बालक की ऑनलाईन पढायी जारी रखने हेतु लगातार निशुल्क रिचार्ज करवाया जा रहा है।
- इसके अतिरिक्त संस्था द्वारा रूकी हुयी फीस जमा किये जाने हेतु भी आश्वासन दिया गया एवं प्राधिकरण द्वारा भी स्कूल से वार्ता की गयी।



## **DLSA UTTARKASHI**

### **1**

An old person belongs to scheduled caste community Mr. Khilla Lal who living below poverty line and has become of 88 years, called PLV Deepak rana from someone's mobile number, On which he called him at district civil court camps Uttarkashi on 11-01-2021 at 2.30 PM. When he approached to PLV, the above legal aid seeker said that someone who belongs to an upper caste community has illegally occupied and possessed over his land which is located in his Village Malla, Tehsil Bhatwari, Uttarkakshi. He told that he is threatening them. Against which he has gone to Patwari, Tehsildar and even inspite of the orders of SDM to Tehsildar, concerned that RSI didn't go on the disputed spot for survey. After listening to him the above PLV called Tehsildar Bhatwari through phone and told him everything was happening with the poor and old aid seeker Mr. Khilla Lal, on the suggestion given by the Tehsildar Bhatwari, the PLV wrote down an application to him, passing an order upon which the RSI and NT went over the land in question for survey and it was proved at the spot that on which the encroachment has been made by the opposite party is the Bhumidhari Land of the old seeker. After confirmation to this fact the PLV have suggested the aid seeker to serve a legal notice to the trespasser through an advocate and later on a procedure of his eviction will be started in the civil court.

Thus according to above tale of victim, the DLSA Uttarkashi helped the old disable victim as a free and competent legal aid system and made a compliance of the policy ACCESS TO JUSTICE FOR ALL.

### **2**

An old person belongs from scheduled caste community Mr. Uday Lal who living below poverty line and has become of 65 years, called PLV Deepak rana through his mobile, PLV called him at district civil court camps, Uttarkashi when he approached to DLSA Uttarkashi, the above Legal aid seeker said that the Nasik legal services authority didn't give him desired information under RTI for which he has requested earlier. And the information that has been given are nominal on the name of RTI. He said that he wants to appeal against the information. The DLSA Uttarakashi instructed the PLV to prepared an first departmental appeal for the Honorable Mumbai SLSA and requested on behalf of aid seeker to provide the whole information. Thus, PLV prepared a letter and suggested the aid

seeker to get this information registered and send to Honorable SLSA Mumbai and wait till the next 30 thirty days according to RTI appeal provision.

Thus according to above tale of victim, the DLSA Uttarkashi helped the old poor victim whose only son late Rajbeer was suspiciously murdered in Nitant Dhaba/ hotel Nasik Maharashtra in 2014, as a free and competent legal aid system and made a compliance of the policy ACCESS TO JUSTICE FOR ALL.

### 3

A poor and senior citizen Mr. Bhagwan Singh Son of Shri Nathi Singh resident of remote Neogaun, Tehsil Dunda, Uttarkashi called through phone call to PLV Deepak Rana on February 01, 2021 and asked to meet at court Campus Uttarkashi. The poor aid seeker came along with two persons of his village and told the PLV that his Son Mr. Shishpal Singh has become violent on account of his mental disturbance from last few months and the mentally ill Shishpal Singh is attacking on everyone frequently whosoever passes away on the way. To control and avoid any major loss by the person mentally sick in his insanity, his father Bhagwan Singh told that they have roped off his son.

Aid seeker Bhagwan Singh requested to take his mentally sick son Shishpal Singh in police custody and send to mental asylum through court and sought for free legal aid. To legally assist the poor aid seeker aforesaid PLV took necessary guidelines from this DLSA office and the instruction given to the above PLV he prepared an application for honorable CJM Court under mental health act. On which he prayed to take him custody and send to mental asylum. Application was submitted before court through panel lawyer Mr. Amit Aswal Advocate On which the honorable court heard the application and finally passed an order to send the mentally sick in mental asylum Selakui, Dehradun. The regional revenue sub inspector took the mentally sick to Selakui on February 04, 2021 and he was admitted at their till 12-02-2021 and now is at his home after recovery of his health. His mental health is better than before.

Thus according to above tale of victim, DLSA helped the old disable victim as a free and competent legal aid system and made a compliance of the policy ACCESS TO JUSTICE FOR ALL.



An unfortunate natural disaster occurred in the village Raini, District Chamoli on 07<sup>th</sup> February, 2021. It has been report that number of labourers work in Hydro Power Project and other construction works in the disaster sites and its surroundings areas. The disaster victims and their family members may be in need of legal aid and assistance with regard to their legal issues like; rehabilitation and compensation etc. Uttarakhand SLSA in coordination with DLSA Chamoli has created a helpline for assistance of the victims by appointing Retainer Lawyer and Panel Lawyer. The helpline numbers were circulated throughout the country with the help of all State Legal Services Authorities.
