NOTIFICATION

In exercise of the powers conferred by Section 29A of the Legal Services Authorities Act, 1987 (Act No. 39 of 1987), the Uttarakhand State Legal Services Authority hereby makes the following regulations further to amend the Uttarakhand State Legal Services Authority (Transaction of Business and other Provisions) Regulations, 2006 and its subsequent Amendment Regulations, 2017 and 2022, namely:-

1. (1) These Regulations shall be called the Uttarakhand State Legal Services Authority (Transaction of Business and Other Provisions) Amendment Regulations, 2024.
- (2) They shall come into force from the date of notification by the Uttarakhand State Legal Services Authority.
2. The existing **Appendix-"A"** relating to Fee Schedule, which was notified vide Notification No. 933/III-C-2017/SLSA, dated 23rd September, 2017 and Notification No. 175/SLSA/2022, dated 16th February, 2022, is hereby amended and substituted in Para-13.6 of the Uttarakhand State Legal Services Authority (Transaction of Business and Other Provisions) Regulations, 2006. 
