Whereas on 28th January, 2025, this Court reviewed the compliance of directions issued during the previous hearing on 7th August, 2024. Dissatisfied with the level of compliance, the Court allowed time till 5th February, 2025, to submit the Access Audit Report or at least the order of engagement of an Access Auditor vide RoP dated 29th January 2025.

- 4. In view of the above, this Court has now decided to impose a penalty of ₹10,000/- each on all respondent establishments which have not complied with the mandatory accessibility standards, and this Court's direction. A list of all such respondents is enclosed at **Appendix-A**.
- 5. The amount of penalty shall be deposited with the national fund created under Section 86 of the Rights of Persons with Disabilities Act, 2016 whose account details are as under:

- 6. It is further informed that after 28th February, 2025, a fresh review will be undertaken and all respondent establishments which continue to remain non-compliant shall be imposed with a higher level of fine in terms of the provisions of Section 89 the Rights of Persons with Disabilities Act, 2016.
- 7. This is issued with the approval of the Chief Commissioner for Persons with Disabilities.
