I bring into your kind notice the case of a blind woman viz Safeena Wali Daughter of Late Wali Mohammad lone Resident of kupwara Kashmir. She can be contacted 9541448002. She has been facing blindness and has lost her father in tender ages. The widow mother supported three blind sisters to seek education. Safeena appeared in selection test for multitasking post under Roll No: 2201033683 selected by staff selection commission for multitasking post after appearing in the selection test under Roll No 2201033683 under 40004827493 in 2023, She was selected for the post under Selection letter NO: F. No: A-20012/160/2023Admn Dated: 1st January 2024. She has been given central Administrative Tribunal department branch Banglore. She went Banglore for document verification. They informed the candidate with blindness that there was a computer error that column for class 12th has been written in class 10th and vice versa. The Director CAT Banglore Wrote communication to Staff Selection Commission, CGO Complex Lodi Road New Delhi with the plea that error in application form of Safeena should be rectified so that she could join the services. Safeena has been pursuing her case of rectifying the mistake in form from last 9 months But SSC administration failed to rectify a simple error in the application form of a blind girl. Thus violating the Rights of Persons with Disabilities act 2016.CAT Banglore branch has agreed to give post to safeena but SSC office is not correcting the mistake. Thus the woman with blindness has been suffering for last 10 months. She has been waiting in Delhi for justice at the gate of Staff Selection commission but nobody has been listening. It is important to mention that persons with visual disabilities are dependent on Common service centre people or computer operators to fill the forms. They don't have access to computers on their own hence the Typhoo's happen in case of persons with visual disabilities. Safeena has old aged mother and two blind sisters thus no male member is available to pursue her case. She has been living in Delhi and pursuing the SSC Office but no one is beaconing her calls. As all the officials in SSC fail to deliver Justice in favour of Woman with disability Hence it became important to bring the matter in your highnesses notice to request for intervention and serving the Justice as mandated by the Constitution of India and RPWD Act 2016.



# Madam /Sir,

I am directed to enclose a copy of documents related to the complaint dated 16-10-2024 of Ms. Safeena Wali, a person with 50% Low-Vision on the above-mentioned subject, which is self-explanatory.

- 2. Whereas Section 3 of the Rights of Persons with Disabilities Act, 2016 hereinafter referred to as "the Act" provides as under:
  - "3. (1) The appropriate Government shall ensure that the persons with disabilities enjoy the right to equality, life with dignity and respect for his or her integrity equally with others.
  - (2) The appropriate Government shall take steps to utilise the capacity of persons with disabilities by providing appropriate environment.
  - (3) No person with disability shall be discriminated on the ground of disability, unless it is shown that the impugned act or omission is a proportionate means of achieving a legitimate aim.
  - (4) No person shall be deprived of his or her personal liberty only on the ground of disability.
  - (5) The appropriate Government shall take necessary steps to ensure reasonable accommodation for persons with disabilities."

- 3. And whereas Section 21 of the Act, mandates that every establishment shall notify Equal Opportunity Policy and shall register a copy of the same with the Chief Commissioner.
- 4. And whereas Section 23 of the Act makes it mandatory for every government establishment to appoint a Grievance Redressal Officer and to inform the Chief Commissioner about such appointment.
- 5. In the event of having no response to this reminder, the matter may be further examined by this Court based on the available records and the proceedings may be undertaken as per sections 76, 77 and 93 of the RPwD Act, 2016.
