1. Gist of the Complaint

- 1.1 The Complainant, with 75% locomotor disability (left lower limbs), filed a complaint dated 18.06.2023 seeking retention in the Haryana Telecom Circle and exemption from transfer.
- 1.2 He is currently a Junior Engineer (JE) at SDE (Commercial), Bahadurgarh, Rohtak BA, Haryana Telecom Circle. Despite being

promoted to JTO (Kerala Circle) through Limited Internal Competitive Examination (LICE) 2021, he cited that relocation 2,500 km away is unfeasible due to his disability and caregiving responsibilities. He argued that denial of retention violates the RPwD Act, 2016 and DoPT guidelines, which require preference for posting near the native place of persons with disabilities.

2. Notice to Respondents:

2.1 Notices were issued on 30.06.2023 and 07.08.2023, directing Respondents to respond on affidavit with supporting documents within the statutory period.

3. Respondent's Submissions:

3.1 The Respondent, in its reply dated 11.08.2023, stated that postings were made per merit, preferences, and vacancy availability. Haryana Circle had no vacancies. The Complainant had listed all 18 circles in his preferences and undertook to serve wherever posted. Promotion, not transfer, policies apply; no transfer requests are entertained for five years post-promotion.

4. Rejoinder by Complainant:

4.1 The Complainant, in his rejoinder dated 15.08.2023, argued that the reply ignored RPwD Act protections and DoPT guidelines, treating him as a general candidate. He emphasised the hardship of distant posting and requested posting near his native place.

5. CCPD Advisory:

5.1 CCPD issued a letter on 19.01.2024, directing Respondents to reconsider the case under statutory provisions and guidelines for employees with disabilities and submit an action taken report (ATR) within 30 days.

6. Action Taken Report on the CCPD Advisory:

6.1 The Office of CGMT Haryana Circle, BSNL, Ambala filed an ATR on 05.02.2024, referencing the earlier reply.

7. Hearing:

7.1 An online hearing was held on 26.05.2025, attended by the following parties on behalf of the Complainant and BSNL representatives:

7.2 The Complainant reiterated his position and stated that PwD reservation was not implemented in LICE 2021. The Respondent explained posting practices and the impact of recent restructuring. The Respondent informed the Court that the Complainant's promotion was reviewed; he was subsequently promoted and posted in Haryana as per his preference.

8. Observations and Recommendations:

8.1 The Court noted that the grievance was resolved as the Complainant had been posted in Haryana. No further grievance remains. Accordingly, the matter is disposed of.
