1. Gist of the Proceedings:

1.1 Mr. Suneel, a person with 70% locomotor disability (Category C - OL), filed a complaint on 20.05.2025 alleging denial of appointment to the post of Assistant Executive Engineer (Electrical) at ONGC under Advertisement No. 1/2025 (R&P). He claimed that, despite being shortlisted for the interview after qualifying the CBT, he was disqualified due to low interview marks and further alleged a lack of transparency and unfilled reserved posts for PwBD candidates. A notice dated 10.06.2025 was issued under Sections 75 and 77 of the RPwD Act for alleged violations of Sections 3, 21, and 23, requiring comments by affidavit within 30 days. In their affidavit dated 09.07.2025, the respondent denied discrimination, explained the merit-based process, and stated that the selection was as per the RPwD Act and relevant guidelines. The complainant filed a rejoinder on 16.07.2025, reiterating his concerns. Proceedings indicated potential procedural lapses in the recruitment process for PwBD candidates. The complainant, via email dated 29.07.2025, however, said he wished to formally withdraw his complaint filed on 20.05.2025 against ONGC.

2. Observation and Recommendation:

2.1 In view of the unequal withdrawal of the Complaint, further action is not warranted in this matter.
