1. 2. RECORD OF PROCEEDINGS

2.1 At the outset, the parties were given a background of the case by reading paragraphs 8, 9 and 10 of the RoP dated 25.07.2025.

2.2 The learned counsel for the Respondent requested a short adjournment on the grounds that the primary counsel, Adv. Rungta could not make it to this hearing due to his engagement elsewhere. The learned counsel from the Complainant strongly objected to this request for an adjournment.

2.3 The Court observed the urgency of the issues and the continuous loss of the child's academic input and decided to schedule the hearing for 19.08.2025 at 9:30 AM.

2.4 The Court clarified that no further adjournment shall be given and the matter shall be concluded in the next hearing. At this stage, the Respondent requested a copy of the rejoinder submitted by the Complainant after the last hearing. The Complainant was directed to share the same with the Respondent.
