RECORD OF PROCEEDINGS

During the hearing, the Complainant reiterated his complaint that the National Trust deregistered the NGO, namely, Jeewan, an organisation working for mentally challenged, disabled, and deaf-mute children, providing residential treatment, education, training, and teacher training for orphaned intellectually disabled children. The

National Trust also discontinued grant-in-aid under the Samarth Scheme to Jeewan without providing any intimation and making alternative arrangements for funds instead of the grants.

- 2. The representative from the National Trust said that in the year 2022, two children died, and one was beaten in the Jeewan. The newspaper reported this incident, and the National Trust was informed. Thereafter, the State Government and the concerned District Administration were contacted. The District Administration inquired into the incident. Based on the inquiry report, the registration of the NGO was cancelled vide letter dated 28.03.2023 and the grants were discontinued by the National Trust. A copy of the letter was also endorsed to the State Nodal Agency Centre in Jharkhand of the National Trust and the District Commissioner for information. The representative also informed that the Child Care Institution, Jharkhand, had deregistered the organisation. The concerned District Administration also informed the National Trust that they were working on the shifting of the beneficiary children to another appropriate centre.
- 3. After hearing the parties, the Court directed the Respondent to obtain the legal status from the concerned Persons with Disabilities Department and/or Social Welfare Department, Government of Jharkhand, and furnish the same to this Court within thirty days from the date of issue of this Record of Proceedings.
- 4. This is issued with the approval of the Commissioner for Persons with Disabilities.
