1. Record of proceedings:

1. The Preliminary hearing was conducted in the above matter before the court on 28.08.2025 and following parties were present:

1.1 The Complainant stated that he has been selected for the post of Assistant Section Officer (ASO) in the Central Secretariat Service (CSS) under the PwD quota. He has been informed that a re-assessment of his disability will be conducted after he joins the service. He

has requested that this re-assessment be conducted prior to his joining, as he is currently employed in a nationalized bank under the Unreserved (UR) category and acquired his disability (Mental Illness) after joining. He is concerned that, if the re-assessment leads to rejection of his candidature for the ASO post, he may risk losing both employment opportunities.

1.2 The Respondent submitted that they have not received any such request from the Complainant. The request is valid and will be accepted.

1.3 The Court stated that the Complaint be remitted to the Respondent, who shall entrust this to the GRO for resolution within 14 days in accordance with Section 23 of the RPwD Act, 2016. The Complainant shall be at liberty to approach this Court in the event of his dissatisfaction with the resolution. This case is closed accordingly

2. This is issued with the approval of the Chief Commissioner for Persons with Disability.
