Hearing: A hybrid hearing in the matter was conducted by the Commissioner for Persons with Disabilities on 29.08.2025. The following were present during the hearing:

- 1. Complainant: Shri Aniket Somde
- 2. Respondent: Dr. Mane, Principal of the College

RECORD OF PROCEEDINGS

- 1. The Complainant, Shri Aniket Somde, alleged harassment and humiliation on account of his 56% Locomotor Disability by his roommate and college friends at All India Shri Shahu Memorial Society IOIT.
- 2. The Court noted the following details: Date of complaint: 16.08.2025; Disability Type and Percentage: 56% Locomotor Disability; Opposite Party: All India Shri Shahu Memorial Society IOIT; List of Documents enclosed: (i) Disability Certificate, (ii) Aadhaar Card, (iii) WhatsApp pictures of various chats. The Complainant has not submitted all relevant documents in support of the allegations; available remedies exhausted: Not mentioned; the complaint does not suffer from delay, res judicata, or estoppel. Matter raised/pending/decided by other Court/Tribunal: Not mentioned.
- 3. During the discussion, the Court asked the Complainant whether he approached the College authority before coming to the CCPD. He submitted that he raised this with one of the faculty members, who took some steps to ease out his problems, but after some time, the accused persons continued with the harassment. The Principal of the College, Dr. Mane, submitted that an internal inquiry was conducted and the delinquent students have been warned, their parents have been informed, and an undertaking on an affidavit has been taken from the students to the effect that such things will not be repeated. The Principal also submitted that they have a very strict anti-ragging policy.
- 4. The Court observed that the issue raised by the Complainant is very serious and as per sections 7 & 92 of the RPwD Act, is an offence punishable by jail term. Considering the stage of life and the future of the students against whom the matter has been filed, the Court was of the view that the matter be remitted back to the Principal of the College, who will personally ensure that there is no bullying, ragging or any other threat.
- 5. Accordingly, the instant matter is closed with the approval of the Commissioner for Persons with Disabilities, with liberty to the Complainant to approach this Court if he is dissatisfied with the redressal by the Respondent.
