RECORD OF PROCEEDINGS

- At the outset, the Complainant submitted that his son, a certified child with 40% SLD (Specific Learning Disability), was systematically denied his right to inclusive education under the RPWD Act by Mayoora School in collaboration with CBSE, Ajmer. He further requested immediate promotion to Class X, along with a mandated support plan and accountability for negligence, which has already cost five crucial months of education.
- The Respondent submitted that an interim reply had already been filed on 31st July, 2025. Respondent further sought 10 days time, however the Court declined as the statutory time limit includes the extended time of (30+15=45 days) is already over.
- The Court gave time to the Respondent till end of the day for submission of written documents.
