## 1. Gist of Proceedings:

1.1 The Complainant, Mr Mohit (Roll No: 1403006010, Rank 15652), selected for the post of Assistant Section Officer (CSS) through CGLE 2024 under the PwD (Other) category, filed a complaint on May 29, 2025, under Section 20 of the Rights of Persons with Disabilities Act, 2016 (RPwD Act, 2016). He alleged a delay in his appointment due to an unjustified objection by the DoPT to his updated disability certificate, causing professional harm, emotional distress, mental harassment, financial uncertainty, and potential discrimination. Key facts include: submission of a valid temporary disability certificate (Certificate No. CH4490919980006233, issued on June 20, 2024, with 65% disability for Mental Illness - Bipolar Disorder Type 1, valid for 5 years) before the cutoff date of July 24, 2024; issuance of

a permanent disability certificate (Certificate No. CH4490919980005201, dated November 20, 2024, with 70% disability based on revised medical evaluation for the same condition); submission of both certificates during document verification for transparency; receipt of a Show Cause Notice from DoPT questioning the updated certificate; and the Complainant's written response clarifying that the permanent certificate was a procedural and clinical update reinforcing eligibility established by the original certificate, not a new claim. He sought equal opportunity in employment, non-discrimination based on disability, reasonable accommodation, and administrative fairness under Section 20 of the RPwD Act, 2016, requesting immediate processing of his joining order based on the original certificate, treating the permanent certificate as reinforcing documentation, and protection against discrimination or exclusion.

1.2 No notices or reminders from this Court to the Respondent are available on record. On September 18, 2025, the Complainant emailed the Chief Commissioner for Persons with Disabilities (CCPD) stating that the DoPT had granted his joining and was satisfied with their action. He wished to withdraw the complaint as the matter was resolved. He attached copies of his Aadhaar and disability certificate for verification and requested an acknowledgement of acceptance. This email was forwarded by the CCPD on September 22, 2025, to associated parties, including advocates and officials. No replies or affidavits from the Respondent (DoPT) regarding the substantive issues of the complaint are available on record.

1.3 No notice of hearing was issued in this matter, as the Complainant's communication on September 18, 2025, explicitly requested withdrawal based on the resolution of the underlying grievance.

## **2. Observation:**

2.1 Upon considering the facts of the case and the material available on the records, including the complaint letter (detailing background, current issue, legal grounds under Section 20 of the RPwD Act, 2016, and prayer for relief), grievance description, enclosures
