1. Gist of the Case:

1.1 Mr Binayak Nahak, a person with 60% LD, filed a complaint dated 16.02.2024, has submitted a formal complaint under Section 80 of the Rights of Persons with Disabilities (RPWD) Act, 2016. He was appointed under the OBC-PwD category in 2013 and initially requested accommodation on disability grounds in 2014. However, he was allotted a room in the International House-A, meant for married PhD scholars, without preference for his disability and in violation of the then-applicable PwD Act 1995. Despite multiple representations and requests over the years—including formal applications, email communications to the House Allotment Committee (HAC), recommendations from the PwD Liaison Officer, and an email acknowledgement from the Director—he was repeatedly denied appropriate housing in C-type quarters, which he is now entitled to as per his designation and seniority.

1.2 Dr. Nahak asserts that the institute continues to ignore the RPWD Act 2016 and DoPT

He seeks directions to be allotted suitable accommodation with necessary modifications as per his disability, and urges that proper policies aligned with the RPWD Act and DoPT guidelines be implemented for the benefit of all PwD employees.

2. Notice issued to the Respondents:

2.1 A notice dated 20.02.2024 under section 75 and 77 was issued to the above mentioned respondent for forwarding to this Court comments on affidavit on the complaint for violation of sections 20 of the Act within the statutory time limit. This was filed by a Reminder dated 22.05.2024

3. Reply/Rejoinder:

3.1 Despite notice and reminder, no reply was filed by the Respondent.

4. Status update on grievance redressal:

5.1 On 12.08.2025 an email was received from the Complainant wherein he informed that efforts are being made to allot him an accommodation on the ground floor to which he will shift when allotted. Acknowledging the intervention of this Court, he wished to withdraw the instant case before the CCPD.

5. Observations and Recommendations:

5.1 In view of the unequivocal withdrawal of the Case by the Complainant and upon reviewing the facts of the case and the available records, it is clear that no further intervention is necessary. Consequently, the case is disposed of with the approval of the Chief Commissioner for Persons with Disabilities.
