RECORD OF PROCEEDINGS

1. At the outset, the Complainant reiterated his grievance, stating that he had rendered services as a certified Sign Language Interpreter for the Respondent University under the guidance of Ms. Sharita Sharma, Project Incharge of ISL translation. He submitted that he had translated a substantial amount of content into Indian Sign Language for classes VI to XII. He claimed that the agreed remuneration was Rs. 1,000/- per three-hour video/session, amounting to approximately Rs. 5,97,500. However, the Respondent has, till date, released only Rs. 3,09,500/- instead of the full amount for the work.

2. The Respondent submitted that Ms. Sharita Sharma, a faculty member in the Department of Linguistics, had been sanctioned a project by the Govt of Tripura, Department of Education, to translate books into sign language. The Respondent University received a total of Rs. 94,99,000/- for the project, consequent upon which Dr. Sharita Sharma engaged the Complainant and others for the work. After processing claims and clarifications, Rs. 3,09,500 was released to the Complainant. The pending amount of approximately Rs. 2,88,000/- was awaiting re-appropriation of funds, which would be completed within 15 days.

3. After hearing both parties, the Court directed the Respondent to comply to settle the pending amount within 15 days. The Respondent was required to submit an Action Taken Report by 17.06.2025. The Court adjourned the case, expecting a positive outcome and settlement of the pending amount, thereby potentially avoiding another hearing.
