RECORD OF PROCEEDINGS

At the outset, the Court sought the status of steps taken by the Respondent pursuant to the hearing dated 30.05.2025. The Respondent submitted that, in compliance with the Court's direction, the Finance Officer had been apprised of the relevant orders. Upon review, irregularities were discovered in the initial approvals and budgetary allocations under the Bureau of Pharma PSUs of India (BPPPI) scheme.

2. The Court directly questioned the Respondent as to whether the University intends to make the payment due to the Complainant. In response, the Respondent stated that the University is inclined to resolve the matter; however, it is presently constrained by the unavailability of funds under the approved salary budget head. It was further stated that, had such funds been available, the payment could have already been effected.

3. The Court further sought clarification on whether the Complainant had been engaged without requisite administrative approval and whether any formal appointment or direction had been issued. The Respondent submitted that, subject to the University's willingness, the possibility of re-appropriating funds from other budget heads could be explored as a viable alternative. The University intends to proceed with the payment and must do so without unreasonable delay; failing which, the matter may be referred for arbitration or mediation, as continued deferment would be inequitable.

4. The Court also inquired whether the Complainant's services were utilised for the BPPPI project. The Respondent affirmed that the Complainant's services were availed under the said project, specifically under the supervision of Dr Sarita Sharma. Nevertheless, it was reiterated that the current salary budget head does not support further disbursement.

5. The Court observed an inconsistency in the Respondent's submissions,

noting that while payment appears to be acknowledged as due, the Respondent simultaneously contends an inability to pay, despite acknowledging prior re-appropriation of ₹4,00,000 and disbursement of ₹3,60,000 to the Complainant.

6. The Court directed the Respondent to submit, within 7 days, a clear and definitive position either explicitly rejecting the claim with stated legal grounds or taking immediate steps to process the payment. The matter will be next heard **on 27.10.2025** in hybrid mode. The exact timing and link will be shared 24 to 48 hours before the hearing. The Court suggested that in the next hearing, both parties must appear fully prepared with conclusive submissions, and no request for adjournment shall be entertained.
