RECORD OF PROCEEDINGS

1. Hearing:

1.1 A hearing in hybrid mode (online/offline) was conducted on **10.07.2025**. The following parties/representatives were present during the hearing:

2. Record of Proceedings:

2.1 The Complainant reiterated the facts of his case regarding his transfer and denial of an exemption despite being a Person with Disability (PWD) and a caregiver to another PWD. The Court asked the Respondent whether they have a transfer policy for PWD employees, to which the Respondent affirmed that such a policy is in place.

2.2 The Respondent read out Clause 11.3 of the said transfer policy, which states:

"11.3 The posting and transfer of specially abled employees may be considered by the competent authority as per the central government guidelines, which stipulate that such a person may be given a posting as far as possible, subject to the administrative convenience near their native place."

2.3 The Respondent stated that the Complainant was promoted in 2023. As per the promotion policy, he was posted to Nagpur, which is closer to his hometown, Gwalior, than the other options. The Court inquired if there was an FCI Divisional Office in Gwalior. The Respondent replied affirmatively and stated that the Complainant's transfer request is under review, with a transfer expected at the end of this month or the beginning of the following month.

2.4 The Court sought from the Respondent a written response within 15 days outlining the details and timeline for the Complainant's transfer. A copy of the same should be endorsed to the Complainant, who will be free to file his rejoinder, if any, within a further period of 7 days. The Case will be disposed of based on the written submissions, and there shall be no further hearing in this matter.
