RECORD OF PROCEEDINGS

1. Hearing:

1.1 A hearing was conducted on **20.11.2025** in hybrid mode. The following parties/representatives were present during the hearing.

2. Record of Proceedings:

2.1 At the outset, the Complainant reaffirmed his grievance regarding his transfer on a loan or deputation basis. The Court asked whether he had chosen Mumbai as a preferred station, to which the Complainant clarified that his posting was allotted based on his rank. He subsequently joined the service on 19th December 2023.

2.2 The Respondent requested a short adjournment, within which they will be able to engage an advocate and also file a written reply.

2.3 The Court referred to Section 20 (5) and Section 21, read with Rule 8 (3) (c) of the RPwD Act, 2016 and various other DoPT instructions on the issue of posting and transfer of employees with disabilities and their caregivers.

2.4 The Court observed that any request for additional time should be meaningful and constructive, particularly given the age of the complaint. It may be noted that the process should not be unduly delayed. The Court also directed the impleadment of the CBIC and the Principal Commissionerate at Delhi as the matter involves inter-commissionerate transfer. The next hearing is scheduled for **28.11.2025**.
