### RECORD OF PROCEEDINGS

Whereas Mrs. Shiva Gupta appeared before the Court and submitted that she is the sister of the Complainant and shall be representing him in the hearing. On being asked about any authority letter issued by the Complainant in this regard, she replied in negative. The Court gave a short adjournment and after ascertaining the availability of the Respondent, asked her to come again at 1200 hrs with the requisite authorisation letter.

2. An authorisation letter was received through email from the Complainant's mail id. However, the name mentioned in the Complainant's mail did not match with the name furnished by his representative. Mrs. Gupta stated that the Complainant resides with her, however, he was not at home at the time of the hearing. When asked as to how was she able to get the authority letter, she informed that she got the same using the WhatsApp. The Court asked as to why the Complainant can not appear the online hearing when he is available on WhatsApp. Mrs. Gupta could not reply satisfactorily.

3. The Court decided to adjourn the matter and hold the hearing in hybrid mode on **13th February 2025**. The Complainant was directed to be present in the hearing either in person or through VC. The Respondent shall also appear in the hearing.
