## 1. Hearing:

1.1 A hearing was conducted on **01.04.2025** in Online mode through Video Conferencing. The following parties/representatives were present:

# 2. Record of Proceedings:

- 2.1 The Complainant stated that during a joint stock inspection at Kurali with FCI officials, an incident occurred where Mr. Naval and Mr. Chandrakant from FCI (Respondent No. 3) allegedly twisted her hand while attempting to snatch a sample. This resulted in swelling and the need for medical attention, after which she underwent an MLC examination and filed a complaint with the SHO.
- 2.2 Respondent No. 1 submitted that an internal inquiry had already been carried out, and based on the report dated 31.10.2022, they had requested the DGP, Punjab, and the SHO to provide an action-taken report. They also informed the Court that Mr. Naval had filed a separate complaint before the National Commission for Scheduled Castes against the Complainant.

for FCI requested additional time to file their submissions.

2.3 Respondent No. 2 (DSP Shri Mohit) stated that statements from the involved FCI officials and witnesses were recorded, but the evidence was inconclusive. There were conflicting allegations, including claims that the Complainant used casteist slurs against Mr. Naval, and therefore, only a complaint was filed without registering an FIR. Counsel

- 2.4 The Court clarified that sampling-related issues must be raised before the competent authority and that its focus is restricted to allegations of assault on a person with disability. Observing that no proper inquiry report had been placed on record, the Court directed Respondent No. 2 to submit the investigation report within 15 days and instructed Respondent Nos. 1 and 3 to also file written submissions on the issue of harassment and assault within 15 days, with the Complainant permitted to file a rejoinder within one week thereafter. The Case was accordingly adjourned.
