1. Gist of the Complaint:

1.1. Ms Akanksha Sharma filed her complaint on 23.09.2023, requesting a transfer to her native place, Ghaziabad, due to her responsibilities as a caregiver for her husband, who has 60% locomotor disability and is entirely dependent on assistance for his day-to-day activities. She mentioned that she has been employed with Kendriya Vidyalaya Sangathan and is currently posted at KV RHE Pune. Despite making several requests, her department has not addressed her concerns. She is seeking a transfer from Pune to Ghaziabad because her husband is undergoing treatment at AIIMS, Delhi, and travelling from Pune has become difficult for her.

2. Notice Issued:

2.1 The matter was taken up with the Commissioner, Kendriya Vidyalaya Sangathan, on 29-09-2023, citing statutory provisions and government instructions, including but not limited to section 20 (5) of the Act and DoPT OM No. 42011/3/2014-Estt. (Res) dated 08.10.2018.

3. Submissions made by the Respondent:

3.1 In response to the Notice, the Assistant Commissioner (Estt-II & III), KV vide email dated 30.10.2023, submitted stating that the Complainant has been

transferred to Kendriya Vidyalaya, Ghaziabad, pursuant to the transfer order dated 13.10.2023 and that the matter may accordingly be treated as resolved.

4. Submissions made by the Complainant:

4.1 An email dated 19.10.2023 was received from the Complainant stating that, in terms of Kendriya Vidyalaya Office Order No. 11-E-II(046)/TRANSFER/2023/E-II/7792 dated 13.10.2023, she has been transferred to Ghaziabad (Uttar Pradesh).

5. Observations & Recommendations:

5.1 Upon considering the submissions of the parties, particularly the email dated 19.10.2023 of the Complainant, this Court has concluded that no further intervention is warranted in the matter as the grievance of the Complainant has been redressed by the Respondent. The case is disposed of accordingly.

5.2 This is issued with the approval of the Commissioner for Persons with Disabilities.
