RECORD OF PROCEEDINGS

1. Hearing:

1.1 A hearing in hybrid mode (offline/online) was conducted on **26.06.2025**.
 The following parties/representatives were present during the hearing:

2. Proceedings During the Hearing:

2.1 At the outset, the Complainant reiterated his grievance, stating that he had submitted a transfer request on 24.02.2017, which was forwarded to Danapur

Division on 01.08.2018, for approval. However, he has not received any information regarding the acceptance or otherwise of his transfer request. The Complainant also mentioned that another transfer application to the Sonpur Division is pending.

2.2 The Respondent submitted that the Complainant's transfer application was favourably examined and forwarded to Danapur Division vide letter dated 01.08.2018. The Respondent further informed that the Complainant's first transfer application was rejected in 2018, and the second in 2024. The Complainant was notified of the rejection of his application vide letter dated 20.05.2024, because it was not forwarded through the proper channel. The Complainant was advised to submit a fresh application for transfer.

2.3 The Court noted that the matter involved an inter-railway transfer and as such the Railway Board were nominated as the first respondent in the matter. It noted, with due concerns, that no representative from the Railway Board was present online or offline during the hearing to respond to the Court's queries, nor did they inform the Court about their absence in advance. It sought a written response from the Respondent No. 1 within 15 days.
