RECORD OF PROCEEDINGS

1. Hearing:

1.1 A hearing in hybrid mode (online/offline) was conducted on 23.07.2025. The following parties/representatives were present during the hearing:

2. Record Of Proceedings

2.1 At the outset, this Court addressed the grievance regarding non-maintenance of Reservation Rosters from 1996 and to provide reservations to

PwDs in direct recruitment and promotion in compliance with PwD Act, 1995 and RPwD Act, 2016. Observations from previous hearings were also taken into consideration where certain recommendations were given to the Respondent regarding Reservation Roster and promotion of PwD employees at PGIMER, Chandigarh.

2.2 The Court inquired Respondent no. 1 about the appointment of Grievance Redressal Officer (GRO) and maintenance of the Reservation Roster. The Respondent from PGIMER submitted that a GRO has already been appointed and is working for preparation of the Reservation Roster. They also informed that the Complainant had filed his grievance before SCPD also.

2.3 The Complainant submitted to this Court that he has filed a petition on this issue before SCPD in February 2025. He also submitted that till now there are no Reservation Roster has been prepared by PGIMER for promotion of PwD employees.

2.4 The Complainant was informed by the Court that as this matter pertains to a central establishment, and as such the State Commissioner has no jurisdiction over it. Nevertheless, the Complainant may be allowed to withdraw his case, if he so do so. The Complainant submitted that he wants to continue his case in CCPD and will withdraw his case from SCPD.

2.5 After examination it was found that the Reservation Roster has not been submitted by the Respondent as they are in the process of preparation of the same.

2.6 After hearing both the parties, the Court expressed concern over Respondent's non-compliance of direction in the previous hearings and failure to maintain proper Reservation Rosters for PwBDs since 1996, violating the Persons with Disabilities Act 1995, and the Right of Persons with Disabilities Act, 2016.

2.7 The Court had recommended another 15 days time to submit all relevant documents pertaining to the Reservation Roster and its implementation. After examining the documents furnished, if this Courts finds it unsatisfactory then it reserve rights to form Commission under powers exercised by the Chief Commissioner for Persons with Disabilities u/s 77 (1) (e) of the RPwD Act, 2016.
