2.1 The Court noted that this case pertained to the **non-release of remuneration** for services stated to have been provided as **sign language interpreter/consultant services** in connection with a University project, which has been repeatedly heard with no resolution. The Court asked the respondent to state its stance and submissions on whether the University was unwilling to pay.

2.2 The respondent indicated that it wished to pay but cited difficulties relating to the salary head/budget and approvals. The respondent University submitted, *inter alia*, that:

(a) It was not aware of the services taken by the Project In-Charge (PI) and that no offer letter/work order had been issued in the University's records for the stated services;

(b) The project cost was stated to be "about ₹80 lakh+", with about "₹20 lakh" earmarked for human resources/services, and payments to several service providers were stated to have been made earlier, following due procedure.

(c) The difficulty was attributed to a lack of approvals, and reference was also made to allegations of financial irregularity and the constitution of a committee against the PI.

2.3 The complainant submitted, *inter alia*, that:

(a) He was engaged by the PI as the project in charge, coordinated with University officials and shared documents/emails, and asserted that his services were utilised for the University;

(b) The University had paid him earlier on more than one occasion, but the dispute persisted regarding the remaining dues.

2.4 The Court observed that once a professional service has been availed, payment should be made, and internal issues/misconduct (if any) can be dealt with separately as per the University's process. It noted that **the Respondent has been shifting the entire blame for non-release of the remaining dues onto one of its officials, namely the Project In-Charge. However**, despite repeated opportunities, the University had not ensured the presence/representation of the PI. The Court asked the Respondent to submit their versions and submissions made during the hearing on an affidavit within 10 days, which should include:

(a) Clarity on how earlier installment(s) had been paid, from which account/head, and why the balance was now being questioned;
