1. Gist of the Complaint:

1.1 Shri Sudhir kumar Sharma, a person with 55% LD filed a complaint dated 08.06.2022 regarding the denial of double the rate transport allowance.

1.2 He states that as per KVS letter dated 09.09.2011, he has been receiving double Transport Allowance since 01.01.2001. He was granted the selected pay scale in March 2023 through KVS Agra letter dated 03.03.2023. However, despite repeated applications and reminders, the benefit of double Transport Allowance has not been extended in the revised pay scale from January 2021 onwards. He requests that he be granted the eligible double Transport Allowance (₹14,400, i.e., 7200 × 2) as per rules.

2. Notice issued to the Respondents:

2.1 A Notice dated 14.06.2023 was issued to the above mentioned Respondents for forwarding to this Court comments on affidavit on the complaint for violations of Section 20 (1) & (2) of the Act and Department of Expenditure, Ministry of Finance OM No. 21/2008-E-II(B) dated 29th August 2008 read with Ministry of Finance OM No. 21(2)/2011/E-II (B) dated 19th Feb 2014 within the statutory time limit. Since no reply was received from the Respondent a reminder was sent on 24.07.2023.

3. Reply filed by the Respondent:

3.1 The Respondent filed his reply dated 10.08.2023 and clarified that the office informed him that the request of Shri Sharma, TGT (WE), KV Kamla Nehru Nagar, Ghaziabad, had already been examined and approved, and double Transport Allowance was sanctioned through order dated 11.07.2023. Since the benefit has been granted, the KVS stated that the matter may now be treated as closed.

4. Rejoinder filed by the Complainant:

4.1 The Complainant filed the Rejoinder vide email dated 11.09.2023 and stated that he is a retired Work Experience Teacher (TGT grade) from Kendriya Vidyalaya, Kamla Nehru Nagar, Ghaziabad, states that although he was granted MACP/Selection Grade in Level-10 with effect from January 2021, the KVS initially denied him Transport Allowance at double rate applicable to disabled employees. After he approached the Court of the Chief Commissioner for Persons with Disabilities, the Court directed KVS to grant the benefit, and KVS Headquarters accordingly issued orders sanctioning double Transport Allowance with arrears. However, the Drawing and Disbursing Authority has still not implemented the order despite repeated requests. He further reports that even after one and a half months of retirement (31.07.2023), his Retirement Gratuity and CGEIS amounts have also not been paid, though KVS Headquarters has already issued instructions for release of these dues in response to his grievance filed on CPENGRAMS. He highlights that frequent visits to the office, given his disability and recent hip-ball replacement surgery, have worsened his physical difficulties. He therefore requests urgent intervention to pay his Transport Allowance arrears, Gratuity, and CGEIS amounts, along with

interest.

5. Update on the Current status:

5.1 An email dated 27.05.2025 was sent to the above-mentioned parties for forwarding to this Court the current status of the case. Thereafter, it was put to hearing on 26.11.2025.

5.2 An email was received from the above-mentioned Complainant on 25.11.2025 stating that his complaint has been resolved and therefore he wishes to close the case.

6. Observations and Recommendations:

6.1 After considering the submissions from both parties, especially the Complainant's email dated 25.11.2025, the Court has determined that no further intervention is necessary, as the Complainant's request has been acceded to by the Respondent and the travel allowance has been provided to him.

6.2 The case is disposed of with the approval of the Commissioner for Persons with Disabilities.
