**2. Proceedings of the hearing:**

2.1 At the outset, the Court referred to the last Record of Proceedings, wherein the Respondent was directed to ensure the presence of the Project In-Charge. Upon being specifically asked, the Respondent confirmed that the Project In-Charge was not present.

2.2 Mr. Deepak Agarwal, appearing for the Respondent, submitted that the absence was due to the Registrar being on leave and the University being under vacation, resulting in the non-availability of

2.3 The Court expressed serious dissatisfaction with the explanation and observed that repeated non-appearance of responsible officials shows a lack of interest in resolving the matter, causes undue hardship to the Complainant, and results in wastage of the Court's time.

2.4 The Court noted continued non-compliance with its earlier directions, including failure to file the required response relating to payment, project finance, and individual responses.

2.5 The Court found the reasons of leave and vacation unacceptable, particularly in an online hearing, and observed that the matter is highly disturbing, indicating that further inquiry or appropriate proceedings may be initiated.

2.6 The Court directed the Respondent to file their response within seven days from the issuance of this Record of Proceedings, failing which a final order shall be passed in the instant case on the basis of the records available with the Court.
