2. Proceedings During the Hearing:

2.1 At the outset, the Complainant reiterated the submissions made in his original complaint. The Respondent stated that transfers in the Railways are carried out strictly as per the prescribed priority list, under which several Persons with Benchmark Disabilities are ranked above the Complainant and are, therefore, required to be considered first. It was further submitted that the Complainant's transfer request is pending due to an acute shortage of ticket checking staff in the present division. However, they assured that the Complainant would be considered for transfer if a vacancy arises in the next year.

2.2 The Court directed the Respondent to submit a written reply along with relevant supporting documents to substantiate their submissions within 15 days. A copy of the said reply shall be forwarded to the Complainant, who can file his rejoinder, if any, within a further period of 7 days.
