RECORD OF PROCEEDINGS

1. Hearing:

1.1 A hearing in hybrid mode was conducted on **06.01.2026**, wherein the following parties/representatives were present:

2. Proceedings of the hearing:

2.1 At the outset, Respondent No. 2 submitted that they had, by letter dated 18 January 2024, written to the Director and CEO of Adobe Software India Pvt. Ltd. regarding inaccessibility of their products. However, no response was received from Adobe to the said communication. He further submitted that MeitY is only as a facilitator in matters of digital accessibility.

2.2 The representative of Respondent No. 1 (Adobe) submitted that he has recently joined the organisation and was unaware of the complaint and the letter dated 18 January 2024. He sought time for ascertaining the relevant facts.

2.3 The Court sought a detailed written submission on affidavit from both respondents, within seven days. The matter will now be heard on 23.01.2026. The weblink and exact timing of the hearing will be shared with the parties through email 24-48 hours before the scheduled hearing.
