### RECORD OF PROCEEDINGS

1. **Hearing:** A hearing in hybrid mode (online/offline) was conducted on 24.10.2025. The following parties/representatives were present during the hearing:

2. **Proceedings of the Hearing:**

2.1 At the outset, the Complainant, informed the Court that offline concession cards for persons with disabilities are no longer being issued and that, despite a

railway circular allowing UDID cards, applications are being rejected for lack of an offline card. He requested necessary portal changes and clarification.

2.2 The Court sought clarification on the role of Central Railway in addressing a system-wide issue. The Central Railway representative stated that improvements were in progress, a reply had been submitted, and the matter had been referred to the Mechanical Department and the Railway Board.

2.3 The Court noted that the issue is of public interest and has broader implications; the matter is formally admitted in view of its public-interest nature against the Secretary, Railway Board and CRIS. The Court emphasized the need to involve policy-level and implementing agencies to ensure comprehensive resolution.

2.4 Accordingly, the matter has been listed for hearing (online/offline) on 19.12.2025. The web link for the hearing will be provided 48 hours before the scheduled time.

2.5 This is issued with the approval of the Commissioner for Persons with Disabilities.
