2. Proceedings During the Hearing:

2.1 The Complainant briefed about his grievance, stating that he submitted a transfer request to the East Central Railway, Danapur Division on 28.06.2021. Despite a lapse of over 31 months, his No Objection Certificate (NOC) remains pending. He faces significant difficulties due to the considerable distance between his home and current workplace, compounded by the need to care for his elderly parents. He requests that his transfer be processed on compassionate and humanitarian grounds, citing that numerous vacancies have arisen in the Danapur Division due to retirements and direct recruitments. Despite meeting the eligibility criteria, he alleges that his case is being ignored, possibly due to his status as a Divyang employee.

2.2 The Respondent submitted that the Complainant's transfer application, received on 28.06.2021 for a transfer from Sealdah Division to Danapur Division, could not be processed due to the unavailability of vacancies at the time. As per Railway Board guidelines, the Complainant's name was placed at priority number 39, which has since moved to priority number 31 on the transfer list. Currently, there are no vacancies for the post of Senior Clerk in Danapur Division, and the competent authority has decided to issue the No Objection Certificate (NOC) when a suitable vacancy arises.

2.3 The Court directed the Respondent to submit a written response within 15 days, addressing two key points: (i) Details of officials whose request for transfer was accepted since 2021 and whether anyone
