### **RECORD OF PROCEEDINGS**

1. The Complainant, Shri Vishwajeet Rai, having 90% Blindness (benchmark disability as defined under Section 2(r) read with the First Schedule of the Rights of Persons with Disabilities Act, 2016), qualified the SSC MTS examination and completed document verification on 29.04.2025 at the Ministry of Home Affairs. Despite repeated follow-ups, including written representations to SSC Head Office dated 03.06.2025 and 10.07.2025, his

joining has not been processed even after nearly 10 months. The Ministry of External Affairs (MEA) informed the Complainant that the delay is attributable to the non-receipt of scribe details from SSC. On 31.12.2025, the Complainant was further informed that SSC had rejected MEA's request to share the scribe details.

2. The Court noted the following details:

- 2.1 Complaint date: 31.12.2025
- 2.2 All relevant documents submitted
- 2.3 No delay, res judicata or estoppel
- 2.4 No other court/tribunal proceedings informed

3. The grievance concerns inordinate administrative delay in processing the appointment/joining of a selected candidate with a benchmark disability in a reserved post, arising from inter-departmental non-coordination between the recruiting body (SSC) and the user Ministry (MEA) regarding scribe-related details. This prima facie constitutes a failure to provide reasonable accommodation in employment, in violation of Sections 3, 20, 34, and 42 of the RPwD Act, 2016, read with DEPwD guidelines on scribe facilities for PwBD candidates and guidelines on expeditious processing of appointments for PwBD persons.

4. Directions of Hon'ble Commissioner:

- 4.1 SSC to be impleaded as a co-respondent.
- 4.2 Both respondents to file detailed replies/affidavits by **19.01.2026** explaining:
  - (a) Reasons for non-sharing of scribe details,
  - (b) Compliance with scribe and appointment guidelines,
  - (c) Steps taken for the Complainant's joining, and
  - (d) Any lapses/remedial action.

5. Accordingly, the instant matter is admitted for hearing on the merits. RoP-cum-Notice is issued to both respondents, to appear/show cause and file replies as directed, with the next date of hearing fixed as **20.01.2026** for consideration and further proceedings. The Complainant is at liberty to file any additional documents or rejoinder, if so advised.
