1. Hearing: A personal hearing in the hybrid mode in the matter was conducted by the Commissioner for Persons with Disabilities on **22.07.2025**. The following were present during the hearing:

2. Proceedings during the hearing:

2.1 The Complainant, a person with 100% locomotor disability, alleged delays in PhD admission (resolved after prior complaint), guide allotment/topic finalisation (over 1 year), denial of national fellowship eligibility, discontinuation of non-NET UGC fellowship, and threats of hostel eviction despite completing requirements (3 progress reports, 14 research papers, seminars). Sought national fellowship with arrears/back benefits, continuation of non-NET fellowship, and hostel extension.

2.2 The Court sought the reasons from the Respondent for the delay of over a year in guide allotment/topic finalisation (Jan 2022 admission to Feb 2023 allotment) and in the grant of fellowship, etc. The Respondent submitted that they had no prior knowledge of the grievances until this complaint. They also expressed their commitment to strict compliance with the RPwD Act, 2016, including the notification of the EOP and appointment of a GRO. The respondent submitted that the delays were due to mandatory procedures, such as 6-month coursework, DRC meetings, examinations, etc., and that there was no intentional delay. The Respondent also offered the Complainant a non-NET fellowship in accordance with the UGC rules.

2.3 The Court Noted the Respondent's claim of procedural compliance but observed a lack of explanation for specific delays. The Court directed Respondent
