1. Gist of Proceedings:

1.1 The Complainant, Dr. Dhaval Govindbhai Makwana, a person with benchmark disability and resident Jamnagar, Gujarat, filed a complaint dated 01.02.2024 alleging denial of appointment to the post of Assistant Professor (Ayurved Samhita & Siddhant) at National Institute of Ayurveda, Panchkula, on the basis of his disability certificate, despite qualifying the recruitment process under Vacancy Notification No. 1/2023.

1.2. The Complainant stated that his valid disability certificate (issued by GG Hospital-MP Shah Government Medical College, Jamnagar in 2006, 2018, and June 2023) was questioned during reassessment at SMS Medical College, Jaipur, leading to withdrawal of appointment offer without opportunity for clarification. He sought reconsideration, recognition of his fitness, and relaxation under Department of Personnel and Training (DoPT) guidelines for Persons with Disabilities (PwDs), as no other PH candidate was qualified for the said post.

2. Notice Issued to the Respondent (s)

2.1. A notice was issued by this Court dated 22.02.2024 to the Respondents under Sections 75 and 77 of the RPwD Act, 2016, seeking comments on an affidavit regarding compliance with Sections 3, 21, and 23 of the Act, along with relevant government instructions. A reminder was issued dated 22.04.2024 to the Respondents for non-response.

3. Reply received in response to the Notice issued:

3.1. Reply from Respondent No.1 (National Institute of Ayurveda) was received dated 16.05.2024, justifying actions based on medical reassessment. No replies or affidavits from Respondent No.2 (SMS Hospital Medical College) and Respondent No.3 (M P Shah Medical College) are available on record.

4. Rejoinder issued to the Complainant :

4.1. The Complainant submitted a rejoinder dated 13.06.2024, reiterating validity of his certificate and alleging non-compliance with DoPT Office Memorandum (OM) dated 15.01.2018 (validity of old-format certificates) and OM dated 17.05.2022 (non-denial of benefits due to clerical errors).

4.2. Again, on 16.06.2025, e-mail was received from the Complainant wherein through his advocate, the complainant informed that the grievance has been resolved as he was granted appointment to the desired post. He requested withdrawal of the complaint.

5. Observation:

5.1 Upon considering the facts of the case and the documents on the records, especially the Complainant's email dated 16.06.2025, no further intervention is warranted in the matter.
