2. Proceedings during the hearing:

2.1 The Complainant submitted that she was denied PhD admission in 2019 due to the non-implementation of 5% PwD reservation. After the intervention of this Court, admission was granted after two years' delay. An additional five-month delay occurred in supervisor allotment, totalling 2.5 years. Her application for

National Fellowship (NF) was repeatedly ignored/returned by the University instead of being forwarded to UGC/Ministry, resulting in her being placed only on a non-NET fellowship discontinued in May 2025. She is entirely dependent on her retired father. She prayed for directions to the University to process her NF application forthwith and to grant a non-NET fellowship as interim relief (adjustable later).

2.2 The Respondent, represented by Prof. Amandeep Verma (GRO), sought adjournment, stating that senior administrative staff were busy with an upcoming event of the University. The Court rejected the request, noting that the matter is long-pending and further delay is unjustified.

2.3 The Court recommended the Respondent to file a written response (final opportunity) within 7 days wherein the following issues shall be addressed :

(a) Immediate processing and forwarding of the Complainant's National Fellowship application to the Ministry/UGC;

(b) Grant of non-NET fellowship as an interim measure, adjustable upon award of National Fellowship.

2.4 The Complainant shall be provided a copy of the reply and may file a rejoinder, if any, within a further period of 7 days.
