### 1. Gist of Complaint

1.1 Shri Debasish Chakraborty , a person with benchmark locomotor disability submitted a complaint dated 30.04.2023 stating that he is working as an Assistant Manager in Bangiya Gramin Vikas Bank. He submitted that he had been transferred from Paschim Medinipur Region to Purulia Region, which is approximately 200 kilometres away from his residence.

1.2 The Complainant submitted that due to his disability he faces severe difficulty in walking and travelling long distances and requires assistance during travel. He further stated that such transfers are issued frequently despite his disability and requested cancellation of the transfer order in accordance with Government guidelines relating to posting of employees with disabilities.

### 2. Issue of Notice

2.1 The matter was taken up with the Respondent vide notice dated 04.07.2023 stating the provisions of Sections 3, 20, 21, 23, 75 and 77 of the Rights of Persons with Disabilities Act, 2016 read with Rule 8 (3) (c) of the Rights of Persons with Disabilities Rules , 2017 advising the Respondent to submit comments on the complaint along with relevant documents.

### 3. Respondent's Reply to the Notice

3.1 The Respondent Bank, vide letter dated 28.02.2024, submitted that the transfer/posting of Shri Debasish Chakraborty has been made with due consideration of his locomotor disability and that he has largely been accommodated at branches within or near Midnapur town since his appointment in 2007.

#### **4. Rejoinder of the Complainant**

4.1 The Complainant vide email dated 07.08.2025 submitted that the issue raised in the complaint has been resolved and requested that the matter may be treated as closed.

#### **5. Observation and Recommendations**

5.1 Upon reviewing the facts of the case and the available records, particularly the submissions made by the Respondent and the communication received from the Complainant stating that the issue has been resolved, the Court is of the view that the grievance raised by the Complainant stands redressed and no further intervention is deemed necessary.

6. Accordingly, the case is disposed of in these terms with the approval of the Chief Commissioner for Persons with Disabilities.
