2.2 The Respondent, represented by Mr Devashish Chaudhary, submitted that the matter is currently sub-judice before the Debt Recovery Tribunal (DRT). He provided specific references to the ongoing legal proceedings, including Diary No. 254/2026 dated March 7, 2026, and Original Application (OA) No. 633/2017. The Respondents argued that as the core issues are already under the consideration of a competent judicial forum (DRT), the present complaint should not be entertained.

2.3 The Court observed that since the subject matter of the grievance is already pending adjudication before the Debt Recovery Tribunal, it falls beyond the jurisdiction of the CCPD to intervene at this stage. The Court noted that parallel proceedings on the same facts cannot be maintained in this forum while a specialised tribunal is seized of the matter.
