### 1. Gist of the complaint

1.1 Shri Devendra Choumal, a person with benchmark hearing impairment serving as AGM (Genl. Administration) in the Food Corporation of India, filed a complaint dated 06.01.2023 and submitted that he has been transferred from Jaipur near his hometown Jaipur to FCI, DO Bikaner vide Office Order No. 199/2022 dated 27.12.2022. The Complainant further submitted that he had been posted at Jaipur only recently after long service away from his hometown.

1.2 The Complainant prayed for cancellation of the said transfer order and permitting him to continue at Jaipur and be assigned work suitable for a person with hearing impairment.

### 2. Issue of notice

2.1 Taking cognizance of the complaint, this Court issued notice dated 06.01.2023, under Sections 20, 21, 75, 76 and 77 of the Rights of Persons with Disabilities Act, 2016 to the Respondent, calling for comments and the relevant record.

### 3. Gist of the reply

3.1 The Respondent initially filed its reply dated 08.02.2023 in the matter

defending the administrative action concerning transfer/posting. However, during the pendency of proceedings, the Respondent placed on record a subsequent action taken report in response to the communication dated 01.03.2024 issued from this Court. In the said subsequent report, the Respondent specifically stated that the transfer order by which Shri Devendra Choumal had been transferred to FCI, DO Bikaner had already been **superseded** by another office order, namely FCI RO Jaipur Office Order No. 121/2023 dated 28.07.2023, whereby Smt. Preeti Sisodiya was transferred to DO Bikaner.

3.2 The Respondent further stated that Shri Devendra Choumal had been **retained at FCI, RO Jaipur on his request**, and accordingly opined that **no further proceedings were required** in the matter.

#### **4. Gist of the rejoinder**

4.1 The Complainant vide his rejoinder dated 27.03.2024 while accepting that his transfer order for Bikaner was cancelled, raised another issue of being given an additional charge of DO Ajmer.

4.2 The record shows that the core grievance of the Complainant was continuance at Jaipur in place of transfer to Bikaner.

#### **5. Observations**

5.1 Upon considering the records of the case, this Court has concluded that the original complaint was directed against the transfer of the Complainant from Jaipur to Bikaner and sought his retention at Jaipur, which stands resolved. As such, no live dispute survives requiring adjudication on merits in the present proceedings.

5.2 Accordingly, the case is disposed of in these terms with the approval of the Chief Commissioner for Persons with Disabilities.
