1. Gist of the Complaint

1.1 Shri Sandeep, a person with 50% locomotor disability, filed a complaint dated **07.06.2024** regarding the denial of a reservation in promotion to the post of Upper Division Clerk (UDC). He submitted that despite being a person with benchmark disability and in service as LDC, he was not considered for promotion to the post of UDC and his name was not included in the list of eligible candidates for promotion.

1.2 The Complainant further submitted that he was eligible to be considered for promotion along with his juniors and that denial of such consideration amounts to denial of reservation in promotion and is contrary to the provisions relating to rights of persons with disabilities.

2. Notice Issued

2.1 A notice dated 20.06.2024 was issued to the Respondents under Sections 75 and 77 of the Rights of Persons with Disabilities Act, 2016, calling upon them to submit comments on the complaint. The Respondents were further advised to take due care of the provisions of the Act, including Sections 3, 21 and 23, and other applicable statutory provisions and Government instructions.

2.2 A reminder dated 23.07.2024 was issued for non-submission of reply within the stipulated time.

3. Proceedings in the Matter

3.1 The Respondent, vide reply dated 01.08.2024, submitted that the Complainant was not eligible for promotion under the applicable Recruitment Rules as he did not fulfil the prescribed

eligibility criteria and had not participated in the LDCE conducted on 04.08.2022. and further submitted that provisions of the RPwD Act, 2016, are being complied with and reservation in promotion is being implemented in accordance with applicable government instructions.

3.2 A notice for rejoinder dated 10.06.2025 was issued to the Complainant; however, no rejoinder was received within the stipulated time.

3.3 A notice for a hearing was issued in the matter, scheduling a hearing on 10.03.2026. Subsequently, the Complainant, vide email dated 05.03.2026, informed this Court that he does not wish to pursue the complaint further and requested that the case be dropped and the hearing be cancelled.

4. Observations and Recommendations

4.1 Upon considering the records of the case and the submissions of the parties, this Court concludes that no further intervention of this Court is warranted.

5. Accordingly, the case is disposed of in the above terms with the approval of the Chief Commissioner for Persons with Disabilities.
