1. Gist of the Complaint:

1.1 Shri G. Ramanjulu Reddy, a person with 75% hearing impairment, filed a complaint dated 16.10.2023 regarding transfer from GE Wellington, Tamil Nadu, to a location nearer to his native place on medical and disability-related grounds.

1.2 The Complainant submitted that he was facing severe difficulty due to a lack of adequate medical facilities, particularly ENT care, and challenges in communication and daily living on account of his disability. He further sought transfer to Bengaluru, Chennai or Hyderabad in terms of applicable DoPT guidelines.

2. Notice Issued:

2.1 The matter was taken up with the Respondent under Sections 75 and 77 of the Rights of Persons with Disabilities Act, 2016, calling upon them to submit their comments on the complaint; the Respondent was further advised to take due care of the provisions of the Act including Sections 3, 20, 21 and 23, and other applicable statutory provisions and Government instructions. A reminder was also sent to the Respondent on 02.05.2025.

3. Proceedings in the Matter:

3.1 The Complainant reiterated his request in rejoinder dated 25.03.2025, submitting that despite lapse of considerable time, no action had been taken by the Respondent and that DoPT guidelines regarding transfer to native place had not been followed.

3.2 Subsequently, the Complainant, vide communication dated 29.10.2025, informed this Court that he has been posted to Coimbatore, where requisite medical facilities are available, and accordingly sought withdrawal of the complaint.

4. Observations & Recommendations:

4.1 Upon considering the submissions of the Complainant, it is evident that his grievance has been redressed in October 2025 itself, and further intervention of this Court is not warranted. However, this Court notes with due concern the non-responsiveness of the Respondent despite this Court's notice dated 25.03.2025 and reminder dated 02.05.2025. The Respondents are hereby informed that such omission is a punishable offence under Section 93 of the RPwD Act, 2016. Hence, the Respondent is expected to be more careful in such matters in the future.

4.2 The Court observes that non-consideration of disability-specific requirements, including access to appropriate medical facilities and support systems, in matters of transfer and posting, is not in consonance with the principles of reasonable accommodation under Sections 3 and 2(y) of the Act.

4.3 The Court further notes that notice in the matter, *inter alia*, referred to Sections 21 and 23 of the Act, and the Respondent is required to ensure compliance with these statutory provisions, including the institutional grievance redressal mechanism.

4.4 however, the grievance stands redressed and has been acknowledged by the Complainant, and therefore no further intervention is warranted in the matter.

5. Accordingly, the case is disposed of in these terms with the approval of the Chief Commissioner for Persons with Disabilities.
