### **1. Gist of the Complaint**

1.1 Shri Arun Kumar Singh, a person with 50% locomotor disability, filed a complaint dated 18.05.2024 regarding deputation/transfer to a distant location despite his medical condition.

1.2 The Complainant submitted that he is suffering from spondylosis with restricted mobility and is undergoing continuous treatment at Gorakhpur. He further submitted that despite informing the Respondent of his disability status and medical condition, he was deputed to Banda, approximately 415 km away, causing hardship. He further submitted that his representations seeking cancellation of deputation were not considered, and sought posting at a place compatible with his medical condition.

### **2. Notice Issued**

2.1 A notice dated 27.06.2024 was issued to the Respondent under Sections 75 and 77 of the Rights of Persons with Disabilities Act, 2016, calling upon them to submit comments on affidavit along with relevant documents within 30 days. The Respondent was further advised to take due care of the provisions of the Act, including Sections 3, 21 and 23, and other applicable statutory provisions and Government instructions.

### **3. Proceedings in the Matter**

3.1 The Respondent, vide reply dated 12.07.2024, submitted that departmental proceedings had been initiated against the Complainant and that the deputation order had subsequently been withdrawn. The Respondent further submitted that the Complainant had been restored to his original place of posting at Gorakhpur and had joined duties on 08.07.2024.

3.2 A notice for filing rejoinder dated 25.07.2024 was issued to the Complainant.

3.3 Subsequently, the Complainant, vide email dated 17.03.2026, informed this Court that the
