1. Gist of the Complaint

1.1 Shri Shiv Kumar Sahu, a person with 100% visual impairment (blindness), filed a complaint dated 25.03.2025 seeking transfer from Chakradharpur Division to Tatanagar on humanitarian and disability-related grounds. The Complainant submitted that he was working as a Junior Clerk-cum-Typist and was facing severe difficulty due to the absence of accessible working conditions and long-distance travel of approximately 85 km daily, along with the responsibility of taking care of his ailing mother. It was further submitted that despite repeated representations, the request for transfer to a suitable post at Tatanagar was not considered, and intervention of this Court was sought.

2. Notice Issued

2.1 A notice dated 02.05.2025 was issued to the Respondents under Sections 75 and 77 of the Rights of Persons with Disabilities Act, 2016, calling upon them to submit comments on the complaint. The Respondents were advised to take due care of the provisions of the Act, including Sections 3, 21, 23 and 20(5), and relevant Government instructions, including DoPT guidelines regarding the posting of persons with disabilities.

3. Proceedings in the Matter

3.1 The Respondents, vide reply and affidavit dated 23.05.2025, submitted that due to restructuring and redeployment of surplus staff, the post held by the Complainant had been surrendered and redeployment was undertaken.

3.2 It was submitted that the Complainant's request was considered and he was redeployed and transferred to Tatanagar (TRS/TATA) in the same category, scale and pay, as per his opted/choice place.

3.3 The Respondents further submitted that the Complainant was relieved on 20.05.2025 and reported at Tatanagar on 21.05.2025, thereby confirming that the grievance stands redressed. The Respondent also submitted copies of the transfer order, the relieving order from Chakradharpur and the charge assumption report from Tatanagar.

3.4 A notice for filing a rejoinder dated 18.08.2025 was issued to the Complainant; however, no further submissions have been received within the stipulated time.

4. Observations

4.1 The Court notes with due appreciation that the Respondents have considered the request of the Complainant and granted transfer to the desired/appropriate location, and the Complainant has already joined the new place of posting. Accordingly, the grievance stands redressed, and no further intervention is warranted.

5. In view of the above, and considering that the grievance has been redressed, the case is disposed of in these terms with the approval of the Chief Commissioner for Persons with Disabilities.
