2. Proceedings of the hearing:

2.1 At the outset, the Respondent submitted that, in compliance with the directions issued during the last effective hearing, detailed written submissions had already been filed, including a full bifurcation of the amount payable to the Complainant, Mr Atul, along with subsequent developments. Respondent also stated that no further information remains to be furnished at this stage.

2.2 The Respondent further submitted that all relevant details relating to the project and the role of the Project In-Charge (Ms. Sarita Sharma) have already been placed on record and are before this Court for consideration.

2.3 The Court inquired about the presence of the Project In-Charge, Ms. Sarita Sharma, who confirmed her presence. Upon being asked to make submissions, she requested permission to keep her camera switched off. The Court observed that the request was not relevant to the present proceedings and that identity confirmation was required.

2.4 After hearing the parties, the Court decided to hold another hearing in the matter on **20.04.2026** and directed that Ms. Sarita Sharma may appear physically before the Court on the next date of hearing, while other parties may attend through video conferencing.
