**1. Gist of Complaint:**

1.1 Mr. Sarvesh Kumar Mishra, a person with 50% locomotor disability, filed his complaint before this Court on 09.12.2024 on the issue of posting to any branch of the Respondent bank near his native place, Kanpur. He is serving as a clerk at the Central Bank of India, Tiwari Pur Sarh Branch. On 13th July 2022, he met with a road accident, resulting in severe fractures to his left femur and right wrist. After undergoing surgery, his femur became shorter, and his wrist mobility is restricted, making it difficult for him to drive.

1.2 Given that his branch was more than 42 km away from his home, he has been requesting a transfer on compassionate grounds to a nearby branch. He states that despite his requests, his deputation to a more suitable branch was

**2. Legal framework Letter** related to posting/transfer/retention of employees with disabilities and caregivers to dependent persons with disabilities was forwarded on 26-12-2024 to the Respondents. However, no response was received from the Respondents.

### **3. Status Update on Grievance Redressal:**

**3.1** There was no further correspondence on the matter. On 8-05-2025, the CCPD sent an email to check the status. This was followed by a response from the Complainant, dated 09-06-2025, indicating that the Complainant had been transferred and that the grievance had been redressed; therefore, he wishes to withdraw his complaint.

### **4. Observation and Recommendations:**

4.1 Upon reviewing the facts of the case and the available records, it is clear that the Complainant's grievance has already been redressed.

4.2 Consequently, the case is disposed of with the approval of the Commissioner for Persons with Disabilities.
