2. Record of Proceedings:

2.1 During the hearing, the Complainant submitted that although he was appointed under the Locomotor Disability category in 1987 and received subsequent promotions, his case for promotion to the post of Senior Reprographer, which became due in 2014, was not considered despite the availability of vacancies under the reservation for Persons with Disabilities. Instead, he was promoted under the General category in 2018, resulting in an alleged delay and loss of seniority and consequential benefits.

2.2 The Respondents, represented by officials of the Survey of India, submitted that the Complainant was promoted as Senior Reprographer under the General category in 2018 and as Assistant Manager under the PwD category in 2025. It was further submitted that a Review Departmental Promotion Committee (DPC) for promotions to the post of Senior Reprographer under the PwD quota for the period 2016-2025 is in progress and is expected to be completed within two months. The Respondents assured the Court that the Complainant's claim would be examined in accordance with the applicable rules and guidelines.

2.3 Upon consideration of the submissions, the Court observed that the implementation of reservation in promotion under the applicable guidelines from 2016 onwards does not preclude consideration of promotion claims that became due prior to that period, provided the employee was otherwise eligible. Accordingly, the Respondents were directed to file an undertaking within 15 days and to complete the process for considering the Complainant's claim for due promotion within 60 days, in accordance with law. The Court further observed that, in the event of non-compliance, the Complainant shall be at liberty to avail appropriate legal remedies. The matter stands adjourned and is listed for further hearing on **30.07.2026**. The Respondents shall ensure the presence of the competent authority on the said date, and no further adjournment shall be granted.
