1. Gist of Complaint:

1.1 Shri Chandrakant Prajapati, a person having 50% locomotor disability working as a Primary Teacher in Kendriya Vidyalaya Sangathan was promoted to the post of Trained Graduate Teacher (English) through a departmental examination but was subsequently transferred on administrative grounds to Kendriya Vidyalaya Bina, about 523 km away from his home town. He submitted that due to his lifelong disability he is fully dependent on his 77-year-old mother for daily activities, making relocation impracticable. Despite the availability of a vacant TGT (English) post at his existing school, Kendriya Vidyalaya BSF Dantiwada and repeated representations to the authorities, his request for posting in his home district on disability grounds was rejected by KVS Headquarters which he alleges to be contrary to the spirit and provisions of the Rights of Persons with Disabilities Act, 2016.

2. Notice Issued:

2.1 The matter was taken up with the Commissioner, Kendriya Vidyalaya Sangathan through a notice dated 08.02.2024, citing statutory provisions and government instructions including but not limited to Sections 20(5) of the Rights of Persons with Disabilities Act, 2016 and DoPT OM No. 36035/3/2013-Estt. (Res) dated 31.03.2014. Final Reminder was forwarded on 22-04-2024.

4.1 The letter containing legal guidelines related to posting/transfer/retention of employees with disabilities and caregivers was issued on 04-10-2024.

5. Status Update on Grievance Redressal:

5.1 The CCPD issued a hearing notice to the parties on 23.01.2026. Subsequently, a reply along with an Action Taken Report dated 15.01.2026 was received from the Assistant Director General (PE-I & RC), stating that the Complainant's grievance had been duly addressed by the department and that the case may be closed. Thereafter, on 27.01.2026, the Complainant also communicated his satisfaction, confirming that his grievance stood resolved.

6. Observation and Recommendations:

6.1 Upon reviewing the facts of the case and the available records, especially the Complainant's email dated 27.01.2026; the Court has determined that no further intervention is necessary as the Complainant's request has been acceded to by the Respondent.

7. Accordingly, the case is disposed of.
