1. Gist of the Case:

1.1 Mr. Jayajit Das, a person with benchmark disability (locomotor disability), filed a Complaint dated 15-01-2024 regarding the denial of one hour compensatory (extra) time in the GATE 2024 examination despite being granted the same facility in all previous GATE examinations.

1.2 The complainant is appearing for the GATE 2024 organized by IISc Bangalore. He had requested one hour compensatory time as provided under PwD provisions (examination normally of 3 hours). However, the GATE 2024 admit card issued does not reflect the grant of compensatory time. He has attached copies of his PwD certificate and previous GATE documents showing a consistent grant of one hour extra time. The examination is imminent.

1.3 Relief sought includes the immediate grant of one hour compensatory time in GATE 2024 and quick disposal of the matter.

In exercise of the powers conferred under sections 75 and 77 of the Rights of Persons with Disabilities Act, 2016 (hereinafter referred to as "the Act"), a notice dated 16/01/2024, and a final reminder dated 20/04/2024 were issued to the above-mentioned respondent for forwarding to this Court comments on affidavit on the complaint within the statutory time limit.

3. Hearing and Status Update on Grievance Redressal::

3.1. Vide Notice of Hearing dated 15.01.2026, the matter was scheduled for hearing on 20.01.2026. In response, the complainant vide email dated 17.01.2026, informed that he had qualified for the GATE 2024 examination. He stated that the matter has been resolved on its own, as the grievance pertained to the 2024 examination, and he no longer requires intervention. Relevant documents, including his GATE 2024 scorecard and other enclosures, were attached confirming his qualification.

3.2 The Complainant appreciated the Court's response but requested not to proceed further, treating the complaint as resolved.

4. Observations/Recommendations:

4.1 Upon considering the facts of the case and the material available on the records, including the Complainant's email dated 17.01.2026 confirming resolution of the grievance, it is apparent that no further intervention is warranted.

4.2 Accordingly, the case is disposed of.
