1. Hearing: A hearing in the matter was conducted on 20.01.2026, wherein the following were present:

2. Proceedings during the hearing:

2.1 The Court noted that the matter arises from a complaint dated 17.01.2024 filed by Ms. Rinky Sinha, a person with 100% visual impairment, alleging that she was incorrectly marked absent in an examination conducted by the University of Delhi despite having appeared for the same. She sought correction of the absence marking and provision of appropriate reasonable accommodation.

2.2 The Court observed that the Complainant could not join the present hearing and

had also remained absent during the previous hearing held on 03.09.2025. It was further noted that no subsequent written communication, apart from the initial complaint, appeared to have been exchanged.

2.3 The Respondent's representative, Adv. Parv Garg, submitted that the University had already filed a written reply dated 22.04.2024. He stated that the Complainant's marksheets records "ER" (Essential Repeat) in the concerned paper, indicating failure to obtain the minimum qualifying marks and not absence.

2.4 The Court sought an updated response from the Respondent. The Respondent's representative stated that the earlier reply was comprehensive but agreed to file an updated response or reaffirm the earlier reply, with any additional submissions, if considered necessary.

2.5 The Court recommended that the Respondent file an updated response, or reaffirm the earlier reply with any additional submissions, within one week from the date of hearing.

2.6 The Court further recommended that, upon receipt of the Respondent's response, the same be forwarded to the Complainant for her rejoinder/comments, if any.

2.7 The Court observed that the matter cannot remain pending indefinitely in view of the Complainant's absence on two consecutive occasions. Accordingly, if the Complainant fails to respond or participate within seven days of receipt of the Respondent's response, the matter may be proceeded with and final orders passed on the basis of the available record and submissions.
