1. Gist of the Complaint

1.1 Mr. Alwin Antony, a person with 50% learning disability (LD), filed a complaint dated 08.03.2024 regarding the transfer of his Death-cum-Retirement Gratuity (DCRG) from ESIC to his present employer, Vikram Sarabhai Space Centre (VSSC), ISRO.

1.2 He stated that he had been serving as Medical Officer at VSSC since 10.02.2021 and had earlier served as Insurance Medical Officer (IMO) Grade-II in ESIC from 09.09.2016 to 31.01.2021, before joining VSSC through technical resignation. He submitted that, despite being eligible for counting of his past service, ESIC had not transferred his DCRG and unutilized leave balance to VSSC, adversely affecting his service benefits, salary fixation and leave credit.

1.3 The Complainant further submitted that, owing to his disability and the need for surgical treatment, non-transfer of his accumulated leave was causing hardship in availing medical leave. He therefore sought directions for immediate transfer of his DCRG and unutilized leave balance to VSSC.

2. Notice Issued to the Respondents

2.1 Notice dated 05.04.2024 was issued to the Respondents, calling for their comments on affidavit regarding the alleged violation of Section 20 of the RPwD Act, 2016, within the prescribed period.

3.1 The Respondents filed their reply dated 07.05.2024. They stated that the Complainant had remained absent from duty from 03.01.2024 to 05.01.2024 without prior approval or intimation and had subsequently applied for Special Casual Leave (SCL) for PwBD employees without initially submitting supporting medical documents.

3.2 It was further submitted that, upon submission of the requisite medical documents on 18.03.2024, the SCL for the said period was sanctioned by the competent authority on 19.03.2024. The Respondents accordingly contended that the relief sought had been granted and requested closure of the complaint as infructuous.

4. Rejoinder Filed by the Complainant

4.1 In his rejoinder dated 03.11.2024, the Complainant stated that ESIC had approved remittance of his DCRG and had issued a cheque of ₹1,99,332/- in favour of the Accounts Officer, VSSC, on 07.10.2024.

5. Current Status

5.1 Notice of Hearing was issued on 23.01.2026 and the matter was listed for hearing on 29.01.2026. However, vide email dated 28.01.2026, the Complainant informed that his grievance had been resolved and requested closure of the case.

6. Observations and Recommendations

6.1 In view of the Complainant's communication dated 28.01.2026 confirming resolution of his grievance, no further intervention is considered necessary.

7. Accordingly, the case is disposed of.
