2.1 The Complainant alleged that he was denied the facility of a scribe during the pre-appointment training examination for the post of Commercial Ticket Collector (CTC), despite producing a medical certificate, and was subsequently terminated during probation on allegations of copying in the examination held on 26.08.2023.

2.2 The Respondents denied the allegations, submitting that the Complainant never requested a scribe. Rather was found copying through CCTV footage, and his services thereafter were terminated following the prescribed procedure. The Court noted the conflicting claims regarding the request for reasonable accommodation.

2.3 In order to adjudicate the matter on the basis of complete records, the Court granted the Complainant 7 days to file a rejoinder along with supporting documents, including proof of the request for a scribe and the relevant medical certificate. The Respondents were directed to file their comments, if any, within a further 7 days thereafter. The matter is accordingly rescheduled for hearing on **09.09.2026**.
