1. Gist of the Complaint:

1.1 Mr. Lalit Kumar, a person with 85% Locomotor Disability filed a complaint dated 15.03.2024 regarding denial of reservation in promotion.

1.2 The Complainant is a person with benchmark disability who was appointed on 18.04.2018 by RRB Allahabad under the disability quota and was initially posted in the Agra Division. On the Complainant's own request, a transfer to the Delhi Division was granted on 07.01.2019. The Complainant is presently working as Senior Train Manager (Goods) at Ghaziabad station. However, in the suitability list for the post of Senior Passenger Train Manager issued by the Delhi Division vide letter No. 561-E/542/Sr Pass.GD/P-1 dated 30.11.2023, reservation for persons with disabilities was not provided and the applicant's name was not included, despite the applicant having completed more than two years in Grade Pay ₹4200 (Level-6). This has resulted in denial of the benefit of reservation in promotion.

2.1 A notice dated 08.04.2024 was issued to the above mentioned Respondents for forwarding comments on affidavit within the statutory time limit.

3. Reply filed by the Respondents:

3.1 Respondents have filed their reply dated 25.02.2025 and stated that a panel for promotion from Senior Goods Train Manager (GP 4200, Level-6) to Senior Passenger Train Manager (GP 4200, Level-6) was issued on 01.12.2023. As per RBE No. 74/2022 dated 01.07.2022, the Guard category was not identified for reservation in promotion under the PwBD quota, and therefore such reservation was not implemented during the 2023 selection process. However, upon consideration of Mr. Lalit Kumar's request, the competent authority has decided to promote him on a notional basis as Senior Passenger Train Manager from the date of completion of two years of regular service as Senior Goods Train Manager, and on an actual basis from the date of his resumption of duties in the promoted post.

4. Update on the Current status:

4.1 The Notice of Hearing in the matter was issued on 23.01.2026 and it was listed for hearing on 29.01.2026. Prior thereto, an email dated 29.01.2026 was received from the Complainant stating that his grievance had been resolved. The Complainant has accordingly requested closure of the case.

5. Observations and Recommendations:

5.1 After considering the submissions from both parties, especially the Complainant's email dated 29.01.2026, the Court has determined that no further intervention is necessary, as the Complainant's grievance has been resolved.
