1. Gist of the Complaint

1.1 The Complainant, Shri Kartikey Singh, a person with benchmark locomotor disability, submitted a grievance dated 20.04.2026, contesting that he had qualified the AIIMS Common Recruitment Examination (CRE) under Group Code 02, securing All India Rank 165 and OBC-PwBD Category Rank 2. It was submitted that despite his merit, his candidature had been cancelled, and he had been denied participation in the choice filling process for seat allocation. The Complainant contended that a vacancy under the UR-PwBD category at ICMR, Delhi ought to have been allotted to him as reservation for persons with benchmark disabilities is horizontal in nature and extends across all social categories, subject to fulfilment of the prescribed eligibility conditions. The Complainant further submitted that he fulfilled the prescribed age criteria after availing the applicable relaxation for persons with benchmark disabilities and that no candidate with higher merit in the PwBD category was available for the said vacancy. Accordingly, the Complainant prayed for restoration of his candidature and allotment of the vacancy on the basis of merit.

2. Hearing

2.1. A hearing was conducted on 23.07.2026 in hybrid mode, wherein the following parties/representatives were present:

3. Record of Proceedings

3.1 The Respondent submitted that the subject matter of the present complaint is already pending adjudication before the Central Administrative Tribunal (CAT) in O.A. No. 1567/2026, wherein the Tribunal has directed that the result relating to the disputed post be kept on hold. It was further submitted that the recruitment examination was conducted for multiple participating institutions and that the vacancies, including those reserved for persons with benchmark disabilities, were reported by the respective institutions in accordance with their approved reservation rosters and were compartmentalized into different vertical categories, namely UR, OBC, SC and ST. The Respondent submitted that the Complainant, being an OBC candidate, could not be considered against a vacancy earmarked under the UR-PwBD category in accordance with the vacancy position reported by the concerned institution. It was further submitted that AIIMS merely conducts the examination and allots candidates against the vacancies as reported by the participating institutions. The Respondent also informed the Commission that a public notice had already been issued clarifying that the result pertaining to the concerned post would remain subject to the outcome of the pending proceedings before the Central Administrative Tribunal.

3.2 Upon hearing the submissions of both parties, the Court observed that the Respondent had specifically stated that the issues raised in the present complaint are substantially identical to those pending before the Central Administrative Tribunal in O.A. No. 1567/2026 and that the recruitment process concerning the disputed post has been kept subject to the outcome of the said proceedings. The Court also sought confirmation from the Complainant regarding the pendency of the matter before the Tribunal.

3.3 The Court observed that the same cause of action cannot ordinarily be pursued simultaneously before two different judicial or quasi-judicial forums. In view of the admitted pendency of the dispute before the Central Administrative Tribunal involving the same subject matter and parties, the Court considered it inappropriate to entertain parallel proceedings in the present complaint. Consequently, the Court has
